Directions to Trial Site

From Washington DC & Points North. Take I395 to I495 north; follow I495 north to I66 west. Follow I66 west to Virginia RT 234 south (bypass). Follow Rt 234 south (bypass) to the 5th traffic light (Business 234) turn left. Proceed approximately one mile to the Fair Grounds. Entrance on the left.

From Richmond, VA & Points South and East. Take I95 north to Route 234 north (Dumfries Road) Exit 152. Follow Rt 234 approximately 14 miles to Business RT 234. Turn right. Proceed approximately one mile to the Fair Grounds entrance.

From Frederick, MD & Points West. Take US RT 15 south to I66 east (at Haymarket, VA). Follow I66 to Rt 234 South (bypass). Follow Rt 234 south (bypass) to 5th traffic light (Business RT 234, turn left. Proceed approximately one mile to Fair Grounds Entrance on left.

Inside Fairgrounds. Enter at the main gate (right of Armory). Go straight on that road until you are at a dead end facing trees. Turn left and go past stored motor homes to the corner of the grounds. Turn left and follow the tree line a very short distance to an opening in the trees on your right. Turn right through the trees (you will be facing a horse arena). Follow the dirt road to the left (keeping the horse arena on your right) and you will see 2 sheds and the Agility Fields.
